Carolyn Branagan opened the meeting at 7:00 pm on Monday, July 11, 2022.

Public Forum:

- Norm Gosselin stated he was here about the Diversity & Inclusion agenda item.
- Linda Kirker thanked the Selectboard for serving and seconds what Norm said.

Public Appearances:

- Katharine Otto, VT Department of Transportation Route 7 Corridor: Katharine gave a brief overview of the Route 7 Corridor project and the results from the survey. Katharine asked the Selectboard if there were any questions or comments. Carolyn Branagan asked if the work that is currently being done in Milton is part of this project. Katharine responded that there were different levels of the project and the work that is currently being done in Milton is not related. Katharine informed the Selectboard that there was a total of 218 responses to the survey. General discussion continued with Katharine and the Selectboard. Carolyn asked when the Selectboard would hear from the State again. Katharine responded that they could do another presentation in a few months or give the information to Cheryl to present.
- Bob Harnish & Al Wakefield Diversity & Inclusion: Bob & Al explained the Declaration of Inclusion and informed the Selectboard that 59 other Cities and Towns in Vermont have adopted this and are hoping Georgia would be next. Some Towns have adopted the one already created, some Towns have edited it a little to fit their Town, while other Town's have created their own. The Town of Franklin was there first to adopt the Declaration in 2020. Bob informed the Selectboard that they still follow what the Constitution states and that VLCT has fully endorsed the Declaration and are currently working on a guideline to implement it. Carolyn thanked the gentlemen for there presentation and informed them that this is something that needed to be discussed and they would decide at a later time.

Additions/Deletions/Changes:

Cheryl informed the board that she would like to add the dock at the beach (damages). It looks as if something ran into it. The highway department will work with Josh & Doug to repair the dock.

Doug Bergstrom added a few items to discuss about the beach including tennis courts having mold on them. Doug received a quote from Gene Depot for cleaning the courts, but it is over the purchasing policy quote, so addition quotes are needed.

Doug informed the Selectboard that the gates and doors to the beach have been found opened and wondering if there are others who have a set. Todd responded that the set Cheryl & himself have are a new set this year. Doug stated that when Bob left there was no guidance as to what Josh should be doing next.

Gary stated that all these issues are the reason he feels the Town needs a Public Works person.

Doug also stated that specific hours for opening and closing of the beach should be stated on a sign. The current sign says 9:00 a.m. to dusk, but dusk is different for everyone. When Josh goes to close the beach at night there are still cars in the parking lot. Todd stated that dusk was used in the past as to cover a wide time frame.

Carolyn stated she was looking for a motion to enter executive session under 1 VSA §313 Interim Town Administrator, Cheryl Letourneau to discuss personnel where premature general public knowledge would clearly place the state, municipality, other public body, or person involved at a substantial disadvantage.

Carl Rosenquist made the motion. Gary Wright seconded. All were in favor.
